**Cohort 7 residential visit to Caythorpe Court, Lincolnshire; Monday 7<sup>th</sup> July to Friday 11<sup>th</sup> July 2025**

As part of our Enrichment Programme at Honywood School, we offer learners opportunities for learning outside of the classroom where they can develop relationships with their peers and staff, whilst developing their confidence and resilience. As you may recall from the C7 Intake Evening and our 'Meet the Learning Group Leader' evening, we launched our C7 Summer Residential to families. This residential opportunity to the PGL Centre, Caythorpe Court in Lincolnshire will take place from 7<sup>th</sup> to the 11<sup>th</sup> July 2025.

Caythorpe Court is a PGL-run centre offering activities such as paddle boarding, wall climbing, archery, climbing walls and zip wires. Learners will travel by coach from Honywood to Caythorpe Court on Monday morning. The children will be on site for the week, staying in chalets. Each chalet contains 4-6 beds (bunk beds) with a bathroom attached. The booking is on a full board basis, however, learners will require a packed lunch on the first day, as they will arrive after lunchtime. They will need to bring a sleeping bag or quilt and pillow as the site supplies a bottom sheet only. They will depart from Caythorpe on Friday 11<sup>th</sup> July after lunch. (A meeting will be held nearer the time giving families more information about the visit arrangements such as a kit list.)

The total cost of the week, which includes all transport costs, accommodation and full board is **£595**. This is to be paid via ParentPay as instalments shown below. The initial deposit is non-refundable should your child withdraw from the visit. (We are bound by the travel companies' terms and conditions, these can be found at: <https://www.pgl.co.uk/en-gb/school-trips/resources/teacher-guide/booking-terms-and-conditions-uk> **Should your child withdraw at any time, any refunds will be in accordance to PGL terms and conditions will be on a sliding scale along with any bank charges incurred.**)
